#### Prof. Neil Cumberlidge

Professor Emeritus, Department of Biology, Northern Michigan University

#### Afrotropical crustacean systematics over the past 40 years

Prof. Cumberlidge is an Emeritus Professor in the Department of Biology, Northern Michigan University (NMU), USA and is the former Department Head of Biology.

EDUCATION: B.Sc. (Hons.) in Zoology, Hull University, UK; Postgraduate Certificate in Education (Biology) (P.G.C.Ed.), University of Durham, UK; Ph.D., in Crustacean Physiology, Hull University, UK; D.Sc., in Freshwater Crab Biology, Hull University, Hull, UK. His research interests focus on the taxonomy, systematics, phylogeny, evolution, biogeography, and conservation of African and Madagascan freshwater crabs. He is Chair of the IUCN SSC Freshwater Crustacean Specialist Group, and he led the IUCN Red List global assessment of the freshwater crabs. From his USA lab he maintains active international research collaborations with fellow crustacean specialists across multiple continents (Europe, Africa, Asia, and the Neotropics) and is still active in crustacean research as a Scientific Associate at NMU.



#### Prof. Moenieba Isaacs

Academic Coordinator and senior researcher at the Institute for Poverty, Land and Agrarian Studies at the University of Western Cape

🚃 Issues faced by small scale fishers in South Africa, with a focus on the west coast rock lobster fishery

Prof. Isaacs is the Academic Coordinator and senior researcher at the Institute for Poverty, Land and Agrarian Studies (PLAAS) at the University of Western Cape. Her research areas focus is on understanding the social and political processes of blue justice for smallscale fishers, gender, fish as part of the food system, fisheries reform, Marine Protected Areas, blue economy and biodiversity conservation in South Africa and southern Africa. She has worked extensively with fishing communities, CBOs and NGOs in Southern Africa and internationally to find policy solutions to the problems to the social differentiation in fishing communities. She is an engaged and reflective scholar and always working on finding creative ways to engage with social processes, decision making and policymaking in the context of diverse civil society interests.



#### **Prof. Kerry Sink**

Marine Programme Manager and Principal Scientist South African National Biodiversity Institute (SANBI)

Unlocking biodiversity data for decisions that make a difference: two decades of research shaping ocean assessment, planning and protection

Prof. Sink is an inspired and dedicated marine conservation practitioner who has led the Marine Programme at the South African National Biodiversity Institute since 2006. She is also an Associate Professor at the Institute of Coastal and Marine Research at Nelson Mandela University. She has led the marine component of the last three National Biodiversity assessments (2011, 2018 and 2025) but much of her current work is focused on the strengthening and expansion of South Africa's MPA network. Kerry led the Offshore Marine Protected Area project (OMPA) that catalysed a network of spatial management measures, including MPAs, to protect offshore biodiversity and support sustainable use of South Africa's oceans.



#### Dr Lara Jane Atkinson (Pr.Sci.Nat.)

Offshore Biodiversity Scientist (NRF-SAEON Egagasini Node)

Unlocking biodiversity data for decisions that make a difference: two decades of research shaping ocean assessment, planning and protection

Dr Atkinson's marine research experience spans academic, industry, consulting and government-based frameworks, enabling expertise in a diverse range of topics and depth of knowledge, incorporating pure and applied research. I have been employed as the Offshore Biodiversity Scientist with the National Research Foundation South African Environmental Observation Network since 2010. Her research focuses on developing and implementing long-term monitoring protocols for the offshore benthic environment, specifically epifaunal invertebrates (animals living on the surface of the seabed) and assessing the impacts of human activities.

- Standard abbreviations may be used for common terms only. Otherwise, any abbreviation should be given in brackets after the first full use of the word. Abbreviations may be used in the title, provided the name in full is outlined in the body of the abstract.
- You will be asked to provide a short biography (up to 150 words) with your submission.
- You will be asked to nominate your preference for poster or oral presentation.
- Please include degrees or professional titles (e.g. Dr, Prof., etc.).
- It is the author's responsibility to ensure the title, author and affiliation details entered in the paper submission site are correct and exactly as they should be published on the abstract and all Symposium materials.
  - o Do not include author names in the title or body of your abstract these are entered online during the submission process.

- Abstracts will be reviewed and authors notified of the outcome of the review process.
